### **Note introductive**

La présente bibliographie est une sélection des ouvrages composant celle sur le thème « Les recours contre les actes des organisations internationales », qui avait été établie pour l'usage des chercheurs du Centre d'étude et de recherche de droit international et de relations internationales de l'Académie de droit international de La Haye. La sélection se fonde sur les sujets principaux traités par les participants au Centre de 2011 et a été complétée jusqu'en mars 2014.

On y trouvera référencés des livres, des articles de livres et de journaux et des essais. La sélection a été élaborée à partir de documents, sur papier ou électroniques, disponibles à la Bibliothèque du Palais de la Paix. En outre, la bibliographie énumère les principaux ouvrages cités dans les notes des articles contenus dans ce volume.

### **Introductory Note**

This bibliography is a selection of the titles in the bibliography on “Remedies for the Actions of International Organizations”, which was prepared for the researchers of the Centre for Studies and Research in International Law and International Relations of the Hague Academy of International Law. The selection is based on the major subjects dealt with by the participants of the 2011 Centre and has been updated until March 2014.

References cover books, articles in books and journals, and essays. The selected items have been compiled from both traditional and electronic sources available in the Peace Palace Library. In addition the bibliography lists the major works cited in the footnotes of the articles contained in this volume.
